**The last date of submission of application is 07.01.2019.** The applications can be submitted in the office of the District Legal Services Authority, Nadia, Sub-divisional Legal Services Committee Ranaghat, Sub-divisional Legal Services Committee Kalyani and Sub-divisional Legal Services Committee Tehatta in between the office hours.

The mode and manner of selection procedure will be informed to the applicants during the process.

Panel of Retainer Lawyers are also be selected from the final panel of lawyers of the District Legal Services Authority, Nadia, Sub-divisional Legal Services Committee Ranaghat, Sub-divisional Legal Services Committee Kalyani and Sub-divisional Legal Services Committee Tehatta in terms of the aforementioned resolution and new amendment of the NALSA Regulation.
